II. **Approval of Minutes from August 9, 2016.** Kregg Aytes moved for approval, Alison Harmon seconded, approved.

III. Topics for Discussion:

- **A.** Faculty Handbook: Emeritus Policy: Kenning Arlitsch proposed a change to the library access language regarding electronic usage. Discussion regarding the use of space/approved by the department may need to be reviewed. Helen Melland moved for approval with recommendations, Brett Gunnink seconded, approved.
- **B.** Center for Wildlife Health and Disease Ecology: The original center was the Center for Bison studies established in 1994 and expanded in 1997 to the Bison and Wildlife Health. This proposal is to change the name to the Center for Wildlife Health and Disease Ecology.
- **C.** Pollinator Health Center: Thirteen afflicted faculty across MSU are working on various issues related to Pollinator Health issues. The Center would assist with grant proposals and graduate education.
- **D.** Western Lands and Peoples Center: Western Lands and Peoples initiative is requesting that a Center destination be granted to continue the work begun under the initiative to include digital environments and resources being made more accessible. A Faculty advisory committee will also be formed to include representation from all colleges and MOR.
- **E.** Minor in Biomedical Engineering: The proposal is a natural progression of engineering with interfacing with the life sciences. The proposal is also meeting a very strong student demand.

The three center proposals and minor proposal were voted on as a group. Kregg Aytes moved for approval, Michael Babcock seconded, approved. All will move forward for the November BOR meeting.
