Full Malt Analysis – for base barley & wheat malts Moisture, FG, CG and F-C Extract, Assortment, Friability, Color, BG, SP, TP, S/T, FAN, DP, AA, Filtration, Clarity, pH.	\$150
Basic Malt Analysis – for base barley & wheat malts (<i>Full tests minus CG Extract and Assortment</i>)	\$100
Adjunct Analysis (<i>For malted adjuncts, Basic tests minus friability & T. Protein</i>) *Must request based on the following options: Adjunct, 1:1 – mashed 1:1 with base barley malt, for low gel temp products needing enzymatic support Adjunct, Pre-Boil 2:3 – mashed 2:3 with base barley malt, a pre boil gelatinizes high gel temp starches	\$150
Specialty Malt Analysis (<i>Moisture, FG Extract, Color, pH</i>) *Must request based on the following options: High Dried - can self-convert - 100% inclusion Caramel - mashed 1:1 w/ base barley malt to support enzymatic conversion Black Malt - very high color - dilute boil extraction – only color/moisture reported	\$75
Enzymes only	\$75
Starch Content	\$50
Cereal Extract (<i>For raw grains. – mashed 2:3 with base barley malt. Typically same measures as Basic, minus friability</i>)	\$150
Glycosidic Nitrile (<i>for distilling malts - only 100g sample needed</i>)	\$225

Sampling & Shipping:

300g per sample required. Samples should be sealed in a moisture proof, 20oz/sandwich size resealable bag, and carefully packaged to prevent opening during shipping. Best practices: Avoid gallon size bags, double bag or tape shut with painters tape. **Samples should be clearly labeled with Product ID/Lot Code, Grain type, Malt Style & Variety** - including more info about your sample helps us provide better data! Please ensure sample is representative of the lot.
