

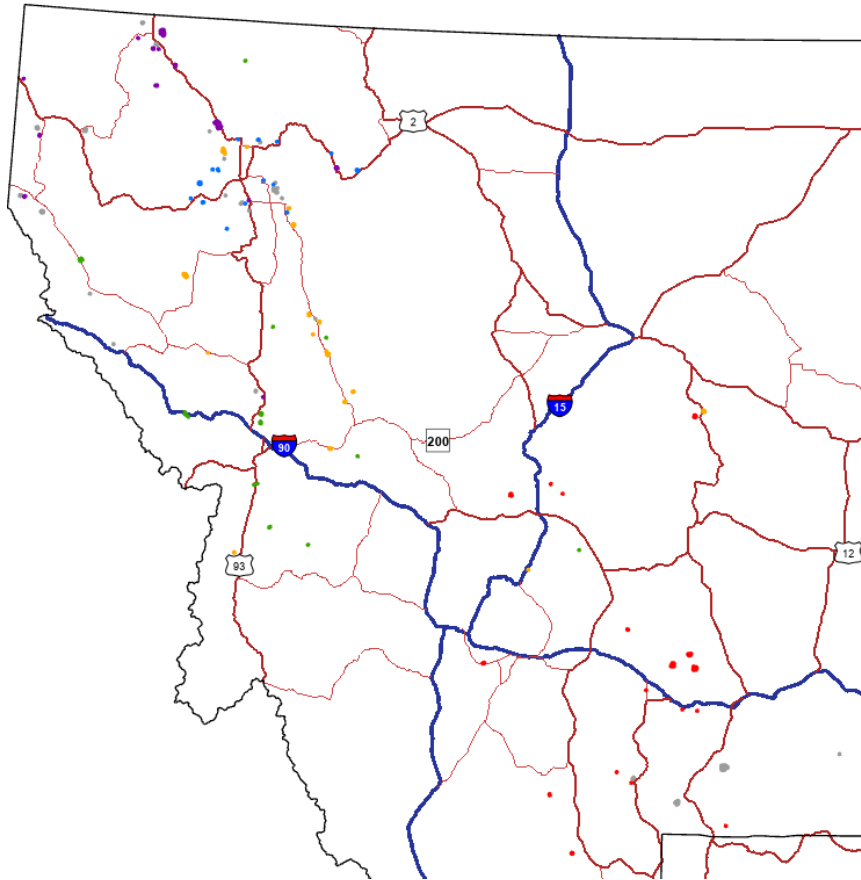

### **Forest Stewardship Monitoring.**

Eighteen ownerships were monitored and 6 were no longer interested, deceased, or deferred the visit to next year. Of those monitored, all were MSU Extension Forestry Stewardship Workshop generated plans. The completed monitoring included 14 Montana Tree Farm landowners. Monitoring visits were completed by various advisors, including 8 by private consultants, 4 by Montana DNRC employees, 14 by certified Tree Farm inspectors, and 2 by volunteer industry foresters from Idaho Forest Group, Stoltze Land and Lumber, and Sun Mountain Lumber).

### **Instructors/Advisors**

Instructor teams included MSU Extension Forestry Forest Stewardship Coordinator, 5 private consultants, 2 MSU Extension Agents/Specialists, 4 DNRC Service Foresters, 1 NRCS Conservationist, and 1 Non-profit organization Conservation Associate (Swan Valley Connections). The workshop visits were assigned as follows: 12 to MSU Extension, 32 to DNRC Service Foresters, 29 to private consultants, 3 to NRCS Conservationists, and 2 to non-profit organization conservation associate. A total of 31 advisors assisted with the program in either teaching and/or conducting workshop and monitoring site visits. By category, there were 11 private consultants, 8 DNRC Service Foresters, 3 MSU Extension personnel, 8 industry foresters, and 1 NRCS Conservationists.
